1. American Recovery Plan Act of 2021 (ARPA)

- a. \$17M ARPA funds to Brookline seeking community input.
- b. Portal was set up to encourage community engagement.
- c. Discussion of priorities of older adults:
 - i. Transportation Uber/Lyft support cut drastically
 - ii. Mental health job positions
 - iii. Jobs for/supporting older adults
 - iv. Food insecurity support
 - v. Technology Including simulcast support, laptops
- d. All believe that COVID has had greatest impact on older adults.

2. Update on Springwell Area Agency on Aging (AAA) meeting 8/24

- c. Priorities match Brookline priorities but feedback is welcome.
- d. Report to provide direction for the AAA efforts/funding.
- e. Based on the Older Americans Act CoA is local and AAA is State and Federal.
- f. AAA no longer providing medical transportation only local.

3. "All the Lonely People" film and campaign on loneliness

- a. Premier screening in Brookline at the Coolidge Corner Theater **December 9**th, **2021** either in person or streaming
- b. Ongoing campaign to end social isolation seeking BrooklineCAN sponsorship
- c. Committee addressing social isolation among older adults.
 - i. Ruthann Dobek is co-chair Churches & Synagogues, Goddard, 2Life, HSL/CCB, Good Shepherd, Friendship Works, and Coolidge Corner Theatre.
 - ii. BrooklineCAN sponsorship requested

 - v. Agreed to support the goals of the campaign, request a specific name for the group.

4. Update on COVID-19 pandemic and impact of Delta variant on BSC operations including Autumn Benefit

- a. Ruthann Delta variant, Dr. Jett leaving, booster shots needed, masks required indoors.
- b. Need to be cautious, flexible and patient.
- c. Newsletter article re guidelines and Senior Center matinees.
- d. Autumn Benefit not in person only virtual, but local businesses will distribute gift cards for donations, and Olive Connection will provide a gift box for top sponsors.
- e. David pointed out that in person meetings with masks impedes lip reading making virtual better for older adults and others.

5. (4A) Warrant Article on obstructions (WA6)

- a. Existing bylaw covers "placed" obstructions 1 hour to fix.
- b. New bylaw includes "covered growth" (hedges) 21 days to fix.
- c. Documentation re street obstruction bylaws and street lighting have both been submitted to the Transportation Board.
- d. Despite all improvement on Winchester Street no improvement on the lighting took place.
- e. Need LCAC support.

6. Treasurers report (John Seay)

- b. 26 memberships 15 paid and 11 free as result of visits to 100 Centre Street and JF&CS.
- c. \$137 is split cost between Senior Center and BrooklineCAN in working with the CoC.
- d. \$5,000 donation in memory of Frank Caro is for health of BrooklineCAN rather than specifically for a memorial.
