a. **Membership**. Bea reported that the committee will be proposing a multi-year sustaining membership. They are also

working on a new mission statement that will be sent to Steering Committee. Once the new mission statement is finalized, we will review the "About the Brookline Community Aging Network" section of the newsletter to see if it needs to be revised.

Ruth distributed a flyer on the May program on eldercare and the committee discussed various aspects of the program, including its scope and its relevance to BrooklineCAN's mission.
- 8. **New Business**. In an effort to promote our goal of building intergenerational networks, a suggestion was made that BrooklineCAN hold an event at the Teen Center. This idea will be brought to Steering Committee and the Education Committee.
