1. Ongoing discussion of BrooklineCAN goals and priorities 2024

- a. Follow up discussion on the recommendation of Livable Community Advocacy Committee (LCAC). Following a discussion of Warrant Article #12, Expansion of the Senior Tax Work-Off Program, at the April 29, 2024 meeting of BrooklineCAN's LCAC, the BrooklineCAN Steering Committee has unanimously voted to support this warrant article and to urge that Town Meeting take Favorable Action on it. This program benefits seniors who need some relief from increasing property taxes and the Town benefits from their work.
 - This approach has been successful so far: (LCAC met, sense-of-the-room was Yes, and email followed to the Steering Committee, in less than 24 hours the Steering Committee members responded with a unanimous approval of support of Warrant Article #12)
 - ii. Susan indicated the process worked well.
 - iii. Consider 75% Steering Committee approval to pass.
