Or a grocery line speech, or a social event exchange – basically, how to capture the essence of BrooklineCAN in a few words, whenever the opportunity presents itself

#### Key attributes to convey

- Advocacy
- Information
- Engagement

#### Words one might use (think of this as a conversation starter)

I'm a member of BrooklineCAN – an all-volunteer organization that focuses on Brookline as a great place to live for seniors and for everyone. We advocate for the ability of older Brookline residents to age in place, to remain engaged in the community and to have access to the information they need to make this possible. Because successful advocacy is at the root of everything we do, we are working to increase our membership to make our advocacy more effective.

#### Sample opportunities to talk about BrooklineCAN

- Someone asks, "Why did you decide to live in Brookline?", or "What do you like about Brookline?"
- Someone asks, "What have you been up to lately?"
- Could be at a dinner party, other social gathering, at church/synagogue, at concert intermission, in a line at the grocery store or bank, or yes, even on an elevator

#### If someone wants specific examples of what BrooklineCAN has done, here's a starting list

- Advocacy
- BrooklineCAN brought together City of Newton and several Brookline Town department to create TRIPPS for transportation alternatives for seniors
- BrooklineCAN monitors sidewalks in winter and advocates for timely snow removal to make sidewalks safer
- Information
- BrooklineCAN provides a periodic newsletter and a website with information on many topics
- BrooklineCAN provides a list of tested (vetted?) local service providers
- (and is always looking for additional trusted service providers to add to the list)
- BrooklineCAN has worked with local businesses to generate a list of restrooms in the neighborhood that are open to those who need them.

• BrooklineCAN sponsors events and presentations that bring together members of the community for learning, information sharing, and socializing [e.g., Conversation Project presentation, Mind-Body Connection presentation, etc.]

• Engagement

• BrooklineCAN engaged residents in Town senior housing to work on a project to include sidewalk safety in their neighborhood

1. Provide a forum for Brookline's seniors to meet directly with Brookline's government officials and candidates for town wide office in both large and small group settings.

2. Be an advocacy voice for the concerns of Brookline's seniors to Town government decision makers and a recognized source of feedback for Brookline officials and groups seeking to know the views of Brookline's older residents.

3. Provide opportunities for Brookline seniors wishing to use their skills and abilities to improve the lives of Brookline seniors and to make Brookline a better place to live.

4. Be a source of useful information about Town of Brookline events, programs, and news of special interest to Brookline seniors and other topics of interest to Brookline seniors.

5. Serve as a catalyst for the creation of new Town of Brookline governmental entities (such as the Pedestrian Advisory Committee), study committees (such as the Moderator's Committee for Elderly Tax Relief), and programs.
